2. About Single Parent Family, etc.

Refers to a family made up of Mother and children, Father and children, Widow, etc. (who did not get married after husband's death).



Mother of Single Parent Family - Boshi Katei no Haha

According to article 6 of the Law on the Welfare of Widows, Mothers and Children, Fathers and Children, a female person who does not have a spouse is defined (widow due to death, separation of bodies due to divorce, disappearance of the spouse without confirmation of life, etc., became a mother without marriage registration, etc.) and currently has a family dependent aged less than 20 years.



Father of Single Parent Family - Fushi Katei no Chichi

According to article 6 of the Law on the Welfare of Widows, Mothers and Children, Fathers and Children, it is defined as a male person who does not have a spouse (widower due to death, separation of bodies due to divorce, disappearance of spouse without confirmation of life, etc.) and currently has a family dependent aged less than 20 years.



Widowed Person - Kafu

It is defined as a female person who does not have a spouse and previously had a family dependent, a person aged less than 20 years.

3. About various systems

We present the requests that can be made by Single Parent Families, etc.
Attention, there are requirements for the request like income, etc.

(1) Jido Fuyo Teate

Consult in person at Iwata City Office Kodomo Mirai-ka, i Plaza 3F Kyufu Group to find out about the necessary documents.

It is an allowance paid to the target child of a Single Parent Family, etc., until the first March 31 after turning 18 and does not share daily expenses with the father or mother or up to 20 years of age when they have a degree of disability specified by Ordinance Government.

Target Person

It is an allowance paid to the target child of a Single Parent Family, etc., until the first March 31 after turning 18 and does not share daily expenses with the father or mother or up to 20 years of age when they have a degree of disability specified by Ordinance Government.

- Children whose parents are divorced.
- The child's Father or Mother has died or is missing without confirmation of life.
- The child's Father or Mother has a severe disability.
- The child's Father or Mother is detained in prison, etc. more than 1 year.
- The child's Father or Mother received the order of protection under the Domestic Violence Prevention Act.
- Child abandoned by Father or Mother for more than 1 year.
- Child born out of wedlock between Father and Mother.
- Child who does not know his Father and Mother due to abandonment, etc.

Monthly Allowance Amount

It is calculated based on the number of children you have custody of and the income of the qualified beneficiary. ※From April 2024.

※Above 4 children will be added to [Full payment (total), 6,450 yen], [Partial payment, 6,440 yen to 3,230 yen] (determined according to income).

※When the beneficiary (Father, Mother, Guardian) or target child receives public pension, the amount of allowance determined based on income will be partially or totally suspended.

※Amounts of allowance sometimes change, every year.

Allowance Payment Day

The allowance will be paid from the month following the month equivalent to the certification request. When the payment day falls on a Saturday, Sunday or Holiday, the deposit will be made on the business day before that date, on the bank's opening day.

(2) Hitori Oya Katei To Iryohi Josei

Of the amounts of medical expenses paid at the hospital/clinic, the part covered by Health Insurance will be reimbursed.

(※It does not cover the fee for the 1st consultation (charged in the absence of a doctor's letter) in a General Hospital, food, etc.)

Target Person

Single Parent Family, etc. who has a registered address in Iwata City and supports a child under 20 years old (until the end of the month 1 day before turning 20) and the Holder (Mother or Father who does not have a spouse) and children are registered in Health Insurance (includes children who do not have a registered address in Iwata due to attending school, etc. in another city).

※There is a requirement such as the Income Tax of everyone in the family living at the same address to be 0 yen (exempt).

(3) Hitori Oya Katei Kosodate Support Jigyo

To reduce the expense of children from Single Parent Families, when using the following programs, (*Byoji-Byogoji hoiku jigyo*, *Enchohoiku jigyo*, *Kyuzitsuhoiku jigyo*, *Family support center jigyo*) part of the fee/expense will be subsidized.

Target Person

Person who meets the requirement level to receive *Jido fuyo teate* (It is possible to receive a public pension in addition to the social assistance pension as an elderly person, even if a person who is not receiving the *Jido fuyo teate* whose income falls within the requirement level to receive the Allowance is considered eligible.)

Program Subsidy Amounts

50% usage fee (disregard below 10 yen).

Documents required for the request.

※It is possible to request from the month following the month of use. Request within one year from the 1st day of the month following use. Once the deadline has passed, it is not possible to receive the subsidy.

【Target Program】

- Child Care Program for children who are sick and/or recovering for illness.
- Program that takes care of the child, beyond the usual hours.
- Program that takes care of children, Sundays, National holidays.

(4) Hitori Oya Katei Jiritsu Shien Kyoiku Kunren Kyufukin

When taking a specific course (according to the list of available courses) to acquire skills and qualifications useful for finding a job, part of the cost of the course will be subsidized.

Target Person

Father or Mother of a Single Parent Family who has a registered address in Iwata City and meets all the following requirements.

- You must be receiving *Jido fuyo teate* or have an income level equivalent to approval of the *Jido fuyo teate*.
- The course you wish to attend and/or its training must be approved as necessary to obtain the appropriate job.
- The applicant has not previously received this benefit in the past.

Designated specific course (1 course per person)

[*Koyo hoken ho no ippan kyoiku kunren kyufukin no shitei kyoiku kunren koza*]

- Course of education and training designated for benefit of general education and training under the Employment Insurance Law

[*Koyo hoken ho no tokutei ippan kyoiku kunren kyufukin no shitei kyoiku kunren koza*]

- Course of education and training designated for specific benefit of general education and training under the Employment Insurance Law

[*Koyo hoken ho no sen mon jissen kyoiku kunren kyufukin no shitei kyoiku kunren koza*]

- Designated education and training course for specialized practical education and training benefits under the Employment Insurance Law

Subsidy Amount Equivalent to 60% of the fee paid for the course.

…For specific courses, amount limit of 200,000 yen.

※When the amount is below 12,000 yen, the benefit will not be paid.

※For a person eligible to receive Employment Insurance education and training benefits, the amount received will be deducted and the subsidy will be paid.

(5) Hitori Oya Katei Koto Shokugyo Kunren Sokushin Kyufukin,

When the Father or Mother of a Single Parent Family takes a course, etc. in a Learning Institution with the aim of acquiring qualifications to get a better job, benefits will be paid to promote training for a specified period.

Target Person

Father or Mother of a Single Parent Family who has a registered address in Iwata City and meets all the following requirements.

- Must be receiving the *Jido fuyo teate* or has an income level equivalent to the approval of the *Jido fuyo teate*.
- Must have completed a certain learning content at a Learning Institution for 1 year or more and have the prospect of obtaining the Qualifying Diploma of the target course (those who started the course from 2021/April/1 to 2024/March/31, more than 6 months).
- It has been assessed that you are having difficulty balancing work or childcare with learning.
- The prospect of obtaining the Qualification Diploma was assessed in the preliminary consultation and the need to take the course was recognized.

(6) Hitori Oya Katei Yoiku Hi Kakuho Shien Joseikin

With the aim of stabilizing the daily life of the Single Parent Family and ensuring the healthy growth of the child, we support part of the expense for the Legal Request for Child Support, such as the expense of requesting a Notarial Document (Kosei shosho sakusei hiyo no ichibu), expense of Process of Judicial Mediation in the Family Court (Chotei moshitate to hiyo no ichibu), etc.

Target Person

- Father or Mother of a Single Parent Family who has a registered address in Iwata, has custody of the child who is subject to the Child Support agreement and currently supports the child.
- Person who has fully paid Municipal Tax or person who has received a deferral of collection or deferral of conversion from the City Office.
- Person who has not previously received this Support Grant in the past.
- A person who has not received and is not expected to receive financial support from the Government Subsidy System or the City Office, with the same objective previously, in the past.

Support Grant Target Expense

- Expense fee required for the preparation of the notarial document required for the Child Support Judicial Request [Limit amount 43,000 yen]
※Items containing compulsory execution approval clauses.
- The cost of purchasing tax seal required for the Child Support Judicial Mediation Process in the Family Court, expense of obtaining necessary documents such as *Koseki tohon* (when Japanese nationality), etc. and expense of purchasing postage seals to apply for documents, etc. [Limit amount 76,000 yen]
※The above eligible expenses, paid after 2023/April/1.
※The amount actually paid within the stipulated limit is subsidized.

- Woman without a spouse who supports a child under 20 of age and a dependent child under 20 of age.
- Man without a spouse who supports a child under 20 of age and a dependent child under 20 of age.
- Young person under 20 who does not have a Father and Mother.

② *Kafu Fukushi Shikin.*

- Woman without a spouse who supports a child over 20 of age and a dependent child over 20 of age.
- Woman aged 40 or over who has no husband or child to support and the previous year's annual income was 2,036,000 yen or less.

<i>Jutaku Shikin</i>	Expenses necessary to repair, expand, renovate, etc. the housing.
<i>Tentaku Shikin</i>	Necessary expenses such as deposit, advance rent, etc. required for the rental contract, to change housing.
<i>Jigyo Kaishi Shikin</i>	Expenses required to open a company.
<i>Jigyo Keizoku Shikin</i>	Expenses necessary to continue the company.
<i>Kekkon Shikin</i>	Expenses necessary for the wedding of the dependent child (includes grandchild, great-grandchild).

※About *Shugaku shikin*, *Shugaku shitaku shikin*, *Shugyo shikin*, *Shushoku shitaku shikin*, *Kekkon shikin*, it will be a joint loan, that is, the applicant and the eligible child, eligible grandchild, etc.

※When lending funds, will be examined if the applicant, guarantor, etc. has ability to repay the debt, etc. The evaluation criteria are different depending on each fund. Also, when necessary an interview, etc. will be held.

※When the person who took out the loan does not make the payment on time, a fine will be charged.

※The requirements for applying for a loan may change without prior notice.

(8) JR company [transport to work] pass-*JR Tsukin Teiki Ken*

When purchasing a transport pass from the JR company, you can purchase it with a 30% discount when *Futsu jōsha ken*.
